KENNEL SITE PLAN

Renewal of Kennel License Only:

Changes to the Kennel Site plan – apply in writing to the By-Law Officer for approval of any changes which would alter the Site plan on file.

New Kennel License: (complete the following Kennel and Site plan)

Diagram of premises and surrounding area showing:

1. Location of all buildings including; kennel areas, dog runs, and any facilities to be used,
2. Kennel area floor plans, and
3. Any neighbouring buildings within 150 meters (500 feet).

Kennels are only permitted in the Agricultural Zone within the Township. New kennels and additions to existing kennels must be located at a distance of not less than 150 metres from a dwelling or commercial, industrial, institutional, and any park and recreation use situated on adjacent lots and must be located at a distance of not less than 300 metres from land zoned in a Residential Zone.
